Welcome back to another CEO Corner and finally it appears some sort of normality is likely to return to WA in the next few weeks with the next phase of COVID-19 restrictions being eased as of Monday 18th May. What will this mean for Shire operations? The Caravan Park and RV area will reopen, increased CRC services and resumption of library services at the Post Office. Our Administration Building is operating as per normal whilst adhering to the relevant social distancing requirements.

With community sports training being given the go ahead to resume, we will see more activity at the FRC and Oval. Ruth will be working with the sporting clubs to outline what the new COVID-19 guidelines entail for use of FRC and associated facilities. There have already been enquiries from sporting clubs regarding meals after training and refreshments at FRC. Whilst commercial cafes and kitchens will be allowed to reopen, at this stage we do not believe that this translates across to community group coordinated catering events. As and when we receive further information on community catering we will communicate this with all sporting clubs who may be interested in operating such an event at FRC in conjunction with their training.

The Works Crew have been busy in the eastern part of the Shire around Holt Rock and "Little Italy" undertaking gravel re-sheets on Holland Track, Allen Rock Road and Kulin-Holt Rock Road. Ryan and his building offsiders continue progress on the kitchen at 38 Day Street as well as various miscellaneous maintenance jobs he gets dragged across to. We have commenced a drainage study with the look to improve drainage on High Street in front of IGA. This will likely involve new catch pits and underground pipes. Hopefully these works can take place in early 2021 following the design.

Next week sees our May Council Meeting. This is a somewhat shortened meeting, due to the seeding commitments of a large number of Councillors, however there will still be a number of key things for discussion. Such things up this month include; reviews of the following key administrative areas Policy Manual as well as Fees and Charges, investigating how COVID-19 may have and potentially will affect current and ongoing budgets, land transactions associated with the Pingaring Dam construction, plus a first glance at potential budget ideas for the 2020/21 Financial Year.

The backend of the financial year is always a busy time for our financial team. This year we are required to update key financial planning documents including our Asset Management Plan and Long-Term Financial Plan, as well as an Asset Revaluation of our infrastructure assets. The updating of this information is the cornerstone work for determining the resources with which our Council will continue to financially operate in a responsible and sustainable manner for the next 5 to 15 years. These documents will also be key pillars in our next review of the Strategic Community Plan and Corporate Business Plan that are due for a major review in 2020/21.

There are a number of rounds of grant funding available and due for submission across the months of May, June and July. The Community Development Team and other relevant staff will be busy compiling applications for the following grants; Regional Economic Development (REDs) and road Blackspot Applications with the WA State Government, plus Heavy Vehicle Safety and Productivity Program (HVSPP) and Drought Community Program (DCP) grants through the Federal Government. These applications will be vital for injecting external financial stimulus into our Council Budget and subsequent community infrastructure.

It is with somewhat disappointment that in recent weeks the community has had to endure vandalism and damage around Kulin townsite, including burnouts throughout town as well as damage to the bowling green. Fortunately, all persons have been identified and dealt with by either Shire officers or the local WA Police. Hopefully we can also get some funding for CCTV around town to assist with the instances of managing such unfortunate incidents.

We continue to thank the community for their on-going understanding and adherence to the COVID-19 restrictions. Until next time safe travels.

# Freebairn Recreation Centre as at 13th May 2020

As things within Western Australia begin to change again with the latest easing of restrictions by the McGowan Government, we see indications that some activities will soon be possible at the Rec Centre. Of course, this is positive news, but as has been the message throughout this pandemic – we cannot become complacent.

There is now a plethora of information from various health professionals, government departments and sports organisations regarding what the requirements will be for a safe return to sport - from grassroots to elite.

There is a lot of information to wade through and the Shire of Kulin will be implementing requirements for clubs to safely return to sport. The first phase of this is return to training.

While each State Sporting Organisation is working on documentation outlining requirements pertinent to their specific sport, we have put together a document that will be circulated to Club Presidents requiring our local sports clubs to adhere to strict guidelines and protocols to facilitate a safe training environment.

Club personnel will be required to sign off on it and take responsibility to ensure that all club members including players and support staff are educated with regard to what is allowed and disallowed. Contravention of guidelines will mean a step backwards with regard to a return to sport.

Below is a snapshot of the guidelines as they currently stand. As we are now becoming accustomed to, with time, the parameters will change again and clubs will be asked to adapt to these changes as they are made at a government level.

- ✓ TRAINING GROUPS OF NO MORE THAN 20 The club can
  undertake training in team groups no larger than 20 people. This includes
  both players & coaches.
- ✓ STRICTLY NO CONTACT The club must advise its participants, coaches, volunteers and parents that all training must be strictly NON-CONTACT (i.e. No Tackling, No Bumping, No Marking Contests, etc).
- 1.5M SOCIAL DISTANCING The club must advise its participants, coaches, volunteers and parents that all training must strictly observe social distancing requirements of 1.5m, and adhere to the requirement of no more than 1 participant per 4sqm.
- NO ACCESS TO CHANGEROOMS The club is aware that all club rooms, changerooms and wet areas are NOT to be used as part of the Return to Training.
- ✓ BALLS ALLOWED, BUT NO OTHER SHARED EQUIPMENT The Club
  is aware that shared balls can be used for small group training, however

- no additional equipment is permitted, and also understands the restrictions in place for small group training.
- ✓ CLUBS & TEAMS UNDERSTAND THE RETURN TO TRAINING
  PROTOCOLS The club and all teams have read, understood and agree to adhere to the Guidelines for a Return to Training
- HYGIENE PROTOCOLS ARE IN PLACE The club must implement good general hygiene protocols and educated players and support staff.
- A REGISTER OF PARTICIPANTS The club must implement a log, or register, to keep a track of which participants are in attendance at all training sessions, and make this available upon request by the Shire of Kulin or health authorities.
- ONLINE EDUCATION COMPLETED Coaches, Presidents & Club Committees must complete the online COVID-19 infection control training prior to commencing training. <a href="https://www.health.gov.au/resources/apps-and-tools/covid-19-infection-control-training">https://www.health.gov.au/resources/apps-and-tools/covid-19-infection-control-training</a>
- LOCAL GOVERNMENT APPROVAL The club has received approval from the Shire of Kulin to access the recreation facilities (ovals, courts, course, greens) for training, and understand that they must follow the direction and advice of Police, Local Government and the SSO at all times.

# Drought Community Support Initiative

The Salvation Army is delivering assistance through the Australian governments Drought Community Support Initiative (DCSI – Round 2). The second round of this assistance commenced on 21 November 2019.

If you are a farmer, farm worker, farm supplier or farm contractor who is doing it tough due to the drought you may be eligible for a one off payment of up to \$3,000.

To be eligible you need to be:

- Over the age of 18 years
- Be an Australian citizen or permanent resident
- Live and / or work in the Kulin Shire
- Have not already received this payment from The Salvation Army or St Vincent de Paul since 21 November 2019

The maximum amount a household can receive is \$3,000. If more than one eligible household members reside in the same residence, the total assistance provided to the household cannot exceed \$3,000.

You can apply for the drought assistance online at <a href="www.salvationarmy.org.au/drought">www.salvationarmy.org.au/drought</a> (preferred method) or by calling the 24/7 Telephone Assistance Line on 1300 551 030. If your preferred method is to call the Telephone Assistance Line, please only use this line to make a new application and please leave a voice message with all the information requested.

The Salvation Army has distributed over \$30 million of this funding to over 10,500 drought affected households since 21 November 2019, and are distributing over \$1.2 million every three days. As you would appreciate, demand for this assistance has been high.

The Salvation Army will call you to complete your assessment as soon as they can. Please do not make a second application if you have already applied as they will get to you. The payment is not considered taxable income. If you had assistance in DCSI (Round 1) which concluded on 30 June 2019 you are eligible to apply for assistance for DCSI (Round 2).


