#### **CEO CORNER**

Welcome back to my first CEO corner for 2022 and hasn't it been a fiery start to February. A couple of stinking days weatherwise last week had everyone on edge. Fortunately, any fires within the Kulin Shire were handled expeditiously by the local VBFB and local farmers. A few Shires to the north were not so fortunate due to the events of Sunday 6th February. Shire staff have provided assistance to these Shires during recovery via plant and personnel.

There was obviously some confusing information issued by DFES late in the evening on Sunday 6th February, once the risk to Kulin townsite had past. At the time there hadn't been any communication from DFES directly with Shire staff or VBFB representatives and the information was incorrect based upon local conditions and knowledge of the situation. At the time Shire staff issued brief communications via our social media to allay potential fears, with a follow up email to the community as early as possible Monday morning. staff will continue to evolve our communication processes during emergency events, however often the focus will be managing the event and communication will be undertaken at appropriate times with appropriate information. Shire staff will continue to work with DFES regarding communication on specific issues that may affect our Shire. The challenge for staff is to manage the information process without causing unnecessary alarm or panic within the community.

Following on from these events the Kulin Town VBFB is always on the look out for new members to train up as local volunteer fire fighters.

Town was certainly busy with tourists over the summer months. The Aquatic Centre and Water Slide continues to attract significant

numbers, particularly on days when the weather conditions are favourable. Well done to Jones and his band of local helpers for their efforts over the summer. I believe there was also some basketball royalty visiting Kulin for a few days in the form of former Perth Wildcat, Australian Boomer and NBA star Paul Rogers who certainly made a BIG impression around the place. Its awesome that our town continues to attract people from all walks of life, although I'm not sure anyone in town was tall enough to rub shoulders with Paul, not even Cyril all though it was not for lack of trying.

#### PROOF OF VACCINATION - RESPONSES TO SECTOR QUESTIONS

WALGA has received the following responses to questions from Local Governments which may assist the sector more broadly.

Question: The Recreation Centre includes a bar which is licensed and the stadium also contains a licensed area (and basketball courts which are used by community sport). It is anticipated that the licensed areas will need proof of double vaccination, so how can community sport be excluded from the requirement as it will be played in a licenced area? The toilets are located inside the licenced area as well.

**Answer:** Proof of vaccination applies to the part of a business where alcohol is supplied i.e. proof of vaccination applies to the part of the venue where alcohol is sold and consumed. If, for example, alcohol is served and consumed throughout both a restaurant and an associated playing field, proof of vaccination would apply throughout. If alcohol was only supplied within a club, proof of vaccination would apply in that location only. If the bar or seated hospitality only operates on certain days, the proof of vaccination requirement will only apply to the venue when the bar or hospitality is operating.

The Proof of Vaccination Directions (No 3) allow for an exclusion of places for transiting: "in an outdoor space where a gathering of persons may be present for the purpose of transiting through the space;" (paragraph 33(0)) and "in an indoor space where a gathering of persons may be present for the purpose of transiting through the space" (paragraph 33(p)).

**Question:** A facility has a range of activities, no gym as such but various places for playing

sport. They have all ranges of ages. In addition, the venue is hired out by community groups/sports to hold youth related activities. They are struggling to determine which areas within their facility would be covered.

**Answer:** Proof of vaccination is not required for community sport, regardless of where it is held. Proof of vaccination would apply to the areas included in the Directions, including rooms/ spaces where group fitness occurs indoors. For example, a basketball court where community sport is being played would not require proof of vaccination, but if the basketball court was instead being used for a fitness class, then proof of vaccination would apply. If the facility serves alcohol or dine-in (i.e. not takeaway) food, proof of vaccination only applies to the location that serves this.

When private events are held in a hired public space it is up to the event organiser to ensure proof of vaccination is checked at a private event held in a public space with proof of vaccination requirements (i.e. if food is served and/or alcohol is served under a liquor license, including under an occasional liquor license). Attendees also have a responsibility to produce their proof of vaccination.

**Question:** Are museums and galleries captured by the proof of vaccination requirement?

**Answer:** Proof of vaccination is only required for the following museums and galleries that are listed in the Directions. All other museums and galleries are not captured by the requirement.

**Question:** Local Government Town Halls (and other community facilities) are frequently hired out for events. Would people entering those facilities at all times require proof of vaccination, or only when

they are hosting an event over 500 people?

**Answer:** The event organiser would need to ensure proof of vaccination is checked at a private event held in a public space with proof of vaccination requirements (e.g. if serving alcohol under a liquor license or providing seated hospitality). Attendees also have a responsibility to produce their proof of vaccination.

**Question:** Local Governments may have facilities which aren't staffed but are open to the public. In terms of requiring proof of vaccination, would information and a request to sign in at the door of the facility be sufficient? That this the approach that is taken currently for SafeWA check in.

It would be a slightly different issue for places like 24-hour gyms, which are unstaffed for the majority of the time. Would such facilities be able to ask their members for proof of vaccination based on their membership of the gym, rather than entry to the facility?

**Answer:** It is up to each business/venue to determine how they implement proof of vaccination checks. Venues that are unstaffed or open 24/7 with managed entry for members may wish to make arrangements for members to bring in their proof of vaccination as a one off and make an appropriate note against their membership.

Businesses that choose to store patrons' proof of vaccination status for ease of access (for example, membership-based gyms that are unstaffed) should clearly inform people how their information will be collected, stored and used. It is the responsibility of the business to meet its legal obligations.



## COVID-19: **Testing and isolation protocols**



### I have tested positive for COVID-19

With COVID-19 in the community, it is important for you to know what to do to keep yourself and others safe. This protocol will help you know when and how long you need to isolate for if you are COVID-19 positive.

If you return a positive Rapid Antigen Test (RAT), you must register your result with the Department of Health.

Isolate at home for 7 days.

# **COVID-19:** Testing and isolation protocols



# I am a close contact and have no symptoms

With COVID-19 in the community, it is important for you to know what to do to keep yourself and others safe. This protocol will help you know what to do if you are a close contact but have no symptoms.

Isolate for 7 days from date of contact.



Monitor for symptoms.



#### **Symptoms**

Refer to 'I am a close contact who develops symptoms' protocol.



No symptoms
Take a RAT

on day 7.



#### **Test positive**

Refer to the 'I have tested positive to COVID-19' protocol.



#### Test negative

You can leave your home after day 7 of isolation, providing there are no new cases in your household. For the next 7 days,

wear a mask indoors and outdoors and don't visit high risk settings (exemptions apply).



#### FRC NEWS - February 2022

Several important messages from me in this edition of the Update:

 FRC Memberships are now overdue!! If you did not receive a renewal letter in the mail, then please contact me or complete the form included in this Update. Payment details are included on the form.

A reminder to those who are members of any of our sporting clubs in town that you are required to hold an FRC membership. With Winter Sports season fast approaching it would be great to have memberships finalised ASAP. Your membership entitles you to use of all Recreation Centre facilities including the gym and hospitality areas and is valid from 1st February 2022 – 31st January 2023.

- Based on the latest health advice, mask mandates and proof of COVID-19 vaccination requirements apply state-wide to the following venues:
- a gym, indoor sporting centre, health club, or dance studio (including a centre offering yoga, barre, pilates, aerobics, dancing,

spin facilities or other fitness class), except when community sport is being played

- People are required to show proof of their COVID-19 vaccination, either in a digital or paper-based form, along with approved identification.
- Proof of vaccination is required in hospitality venues – this includes the FRC Bar.
- Both venues and patrons have a shared responsibility when it comes to proof of vaccination, with venues required to ensure that each patron must produce evidence of their vaccination status and take reasonable steps to ensure patrons do not enter the premises without producing evidence of their vaccination status.

If you have not already, please provide a copy of your proof of vaccination to the Facility Manager – recentre@kulin.wa.gov.au. Thank you for your cooperation. Please be patient with bar staff when they request to see your certification prior to service.

There are races to suit everyone, and the aim of the day is to promote participation, involvement and fun! #### **GENERAL RULES**

- $\dot{}$  The spirit of friendly competition should apply throughout each of the races. Any non-sportsman-like conduct constitutes grounds for immediate disqualification of you or your team
- · Competitors must obey all directions and instructions by officials
- · If you withdraw from the race, please notify the timing team at the finish line
- · It is the responsibility of each competitor to be familiar with the race course
- · A top must be worn during the cycle leg and run leg of the event
- · Competitors are individually responsible for following all traffic laws and road rules, and are solely responsible for the consequences of any infringements
- · A race briefing will be held 10-15 minutes before the first race. All competitors must be present for this briefing regardless of their race time.

#### Swim

- No fins, paddles, snorkels, wetsuits or floatation devices are to be used. Regular swimming goggles are permitted.
- Competitors who warm up must be behind the start line at least two minutes before race start
- Competitors must start in the pool no diving. Any stroke is permitted during the swim leg
- The pool will be patrolled by qualified lifesavers

#### Cycle

- All competitors will be required to wear an AUSTRALIAN STANDARDS APPROVED HELMET throughout the bike course
- The helmet straps must be secured prior to moving the bike from the rack. At the completion of the cycle the bike must be racked prior to unfastening the helmet
- No drafting on the Cycle leg is permitted 5 metres between bikes unless passing
- Competitors must obey the instructions of police, course marshals and other volunteers
- MP3 Players, iPod's, Walkman's etc. are permitted whilst competing.

#### Run

- No form of locomotion other than running or walking is allowed no exceptions!
- All run legs will be on a bitumen or gravel surface
- No individual support vehicles or escort runners are allowed
- Runners are expected to follow the directions of all course marshals and race officials
- MP3 Players, iPod's, Walkman's etc. <u>are</u> permitted whilst competing.

#### Transition Area

- Once the race starts, only competitors who are racing can enter the transition area. This will
  apply until the last cyclist of the race has returned his/her bike to the area No exceptions!
- Make a mental note of your bike placement in the transition area so you can easily find your correct
  position. No flags, signs or tape can be used to identify a competitor's bike rack as it provides an
  unfair advantage over other competitors
- Relay change over for the Teams will take place at the Bike Racks
- Each competitor is ultimately responsible for his or her own gear

#### **SAFETY & MEDICAL RECOMMENDATIONS**

- Drink plenty of fluid before and during the event
- Ensure you have eaten something 1-2 hours before the event
- Bicycles must be in safe mechanical condition for the race and should be checked prior to the race

#### KCCC No bake coconut and date balls

These no bake coconut and date balls contain just two ingredients and they're super healthy

3 cups desiccated coconut

2 cups pitted dates



#### Method

Place 2 cups of coconut and the dates into a blender or food processor.

Are you Aboriginal and over 50?
Are you pregnant?



If you answered YES to any of the above – collect a free pulse oximeter from your local government today!

#### What is a pulse oximeter?

It is a small, peg-like device that clips onto your fingertip to read your heart rate and blood oxygen level. It takes only one minute to work, is reusable and can be shared between other people in your household.

#### Why do I need one?

If you become COVID-19 positive, you may need to be remotely monitored through the WA COVID Care at Home program. By having a pulse oximeter already in your home, a health professional can assess you and provide health advice from the comfort of your home.

Visit WA COVID Care at Home for more information.

#### Where do I get one?

Visit your local government to collect a free pulse oximeter for you and your household (each eligible household can receive one pulse oximeter but supplies are limited).

Do **not** pick up a pulse oximeter if you are already COVID-19 positive. If you have already received a positive COVID-19 test result, the Department of Health will contact you and provide further information.



# Water supply in a bushfire

### This information could save your life

While leaving high-risk bushfires is the safest option, if you plan to stay and defend your home, you must have an INDEPENDENT water supply and pumping capability. This typically requires water tanks of at least 20,000 litres, pump and generator.

This is required as mains water supply and pressure cannot be guaranteed during a bushfire due to the risk of power cuts, fire damage and extreme demand.

Use the Department of Fire and Emergency Services resources to develop your personal bushfire survival plan: mybushfireplan. wa.gov.au. You can also download the My Bushfire Plan app via the App Store or Google Play to access your bushfire plan anytime even without an internet connection.

To support bushfire plans, if you have groundwater bore access to surface water, you can take and store emergency water without it counting against your annual entitlement. For more information on this, and for the location of emergency bushfire water supplies in dryland agricultural areas, visit the Department of Water and

Environmental Regulation website: water.wa.gov.au/fireplanning.

#### **Drinking water**

We recommend you keep a supply of drinking water on hand throughout summer in case your water supply is interrupted.

#### LIFELINE'S CRISIS TEXT SERVICE 24/7 TO HELP MORE AUSTRALIANS

Supported with \$1.5 million in Morrison Government funding, Lifeline has today launched a 24/7 crisis text service to expand its support for Australians struggling with the challenges of the COVID-19 pandemic.

Australians are reaching out to Lifeline's crisis support and suicide prevention services in record numbers, hitting more than 3700 calls in one day last month.

The Lifeline Crisis Support Text Service is now available 24 hours a day, 7 days a week via confidential text message to 0477 13 11 14. Following a few questions via text, Australians are connected to a trained Lifeline crisis supporter. Minister for Health and Aged Care, Greg Hunt, said Lifeline's 24/7 text service is an important expansion of the vital service the charity provides in crisis support and suicide prevention.

"The significant surge in demand for Lifeline's services during COVID means more people are reaching out for help, and services like Lifeline are there to help," Minister Hunt said.

"The expansion of the text service is backed by data showing that it

is the preferred channel for high risk members of the community including young people, those experiencing family and domestic violence, and Aboriginal and Torres Strait Islander people."

"The introduction of the 24/7 service follows a successful 2-year pilot of a limited text service, made possible with \$2.5 million from the Morrison Government."

Lifeline received a record 1,070,860 calls from Australians in crisis in 2021, but managed to increase its average call answer rate to 90.4%. In the same time period, the service also responded to 51,265 text conversations.

The Assistant Minister to the Prime Minister for Mental Health and Suicide Prevention, David Coleman, said the Morrison Government's long partnership with Lifeline was part of its resolute commitment to suicide prevention. "Lifeline's crisis service and the passion of its volunteers mean that no Australian has to experience their darkest moment alone – they literally save lives," Mr Coleman said.

"The 24/7 lifeline crisis support text service makes Lifeline's support available to groups who might otherwise not reach out for help, particularly young people who are often more comfortable using text services.

"The Morrison Government remains committed to working towards zero suicides, backed by our \$2.3 billion investment in mental health and suicide prevention in the 2021–22 Budget, and our ongoing support for Lifeline as Australia's leading suicide prevention agency."

Lifeline's 13 11 14 crisis support service is available 24/7. Australians can speak to a trained crisis supporter any time of the day or night.


